Reference is hereby made to that certain Indenture dated as of December 18, 2019 (as amended, supplemented or modified from time to time, the “Indenture”), among CONSTELLATION OIL SERVICES HOLDING S.A., as issuer (the “Issuer”), the Subsidiary Guarantors from time to time party thereto, and WILMINGTON TRUST, NATIONAL ASSOCIATION, as trustee, paying agent, transfer agent and registrar, relating to the Issuer’s above mentioned Notes. Capitalized terms not otherwise defined herein shall have the meanings ascribed to such terms in the Indenture.

In accordance with Section 9.02 of the Indenture, the Issuer hereby provides notice that the first supplemental indenture to the Indenture (the “Supplemental Indenture”), dated December 30, 2019, is effective. Pursuant to the Supplemental Indenture, Serviços de Petróleo Constellation S.A. (em Recuperação Judicial) (“SPC”) has become a Subsidiary Guarantor under the Indenture. In addition, on December 30, 2019, SPC executed a Grantor Supplement to the Intercreditor Agreement in order to become a Grantor thereunder.

The Issuer hereby also provides notice that as of December 20, 2019, Star International Drilling Limited (“Star International”) executed the Star International Mortgage, and as of such date, the Star International Mortgage is deemed part of the Initial Collateral.
