

QGOG Constellation Announces New Contract for Olinda Star

Luxembourg, July 14, 2014 — QGOG Constellation S.A. ("QGOG Constellation") is pleased to announce that its deepwater rig, the Olinda Star, has been contracted by Karoon Petróleo e Gás Ltda., for operations offshore Brazil. The new contract is expected to commence immediately after the completion of the existing contract with Petrobras. The two-well contract has an estimated duration of 120 days and can be extended to two additional wells. Estimated maximum contract revenues are approximately US\$37 million.

"We are delighted to secure this contract with Karoon and to support their activities in Brazil. The contract demonstrates our ability to capture new opportunities with international players and represents an important step in our strategy of diversifying our client base," said Mr. Leduvy Gouvea, CEO of QGOG Constellation.

Olinda Star is a deepwater semi-submersible drilling rig capable of drilling in water depths of up to 3,600 feet and has a drilling depth capacity of up to 23,000 feet. The latest upgrade in 2009 was carried out by a Brazilian shipyard. Following which, the unit is the only floater drilling rig certified by the Brazilian National Petroleum Agency within Brazilian local content requirements with an index of 38.67%.

QGOG Constellation's offshore fleet comprises twelve units, including nine ultra-deepwater rigs, one deepwater rig and two midwater rigs. In addition, the Company owns nine onshore rigs and is a partner in six FPSOs.
